#25-133D RESOLUTION TO APPROVE ADDITIONAL COMPENSATION FOR DAWN JONES

WHEREAS, Dawn Jones, Director of Career and Transfer Services, has taken on significant additional responsibilities related to securing and implementing new funding sources to expand student internships, including oversight of the Empire State Service Corps program; and

WHEREAS, these responsibilities include evaluating and facilitating grant requests for wraparound support, ensuring alignment with NACE competencies, reviewing student applications, managing HR compliance, leading orientations, overseeing weekly tracking and reporting, compiling data for outcomes, and providing supplemental training; and

WHEREAS, this work is outside of her regular job description and is estimated to require approximately 138 additional hours during the period of January 12, 2026, through June 19, 2026; and

WHEREAS, compensation for this additional work will be funded through the Empire State Service Corps grant (#22638) and will not impact the College's operating budget; and

WHEREAS, Dawn Jones shall receive a stipend of \$423.09 per biweekly pay period for the duration of these additional responsibilities as outlined above, with the total stipend not to exceed \$5,077.02;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Trustees approves

the additional compensation for Dawn Jones as outlined above.

REPORT FROM THE FOUNDATION

The **SUNY Schenectady Fund** is made up of unrestricted donations. These are flexible funds that can be used for most anything.

Most recently, the Foundation utilized these funds to:

- supplement refreshments at STEM Day
- provide white roses and membership dues for 47 Phi Theta Kappa Honor Society inductees
- cover refreshments for the Schenectady Poet Laureate event at the College
- supply baking ingredients for Purple Cupcake Day

Our year-end *Annual Appeal* yields a significant amount of unrestricted gifts. In late November, letters were sent to over **3,300** constituents.

A big thank you to Dr. Moono for hand-signing 763 letters to previous donors. We look forward to sharing the results of this outreach in January.

Recent significant gifts include:

- \$44,000 for the Charlie's Gift Scholarship from an anonymous donor
- Nancy Alexander and her colleagues at Gleason Dunn Walsh & O'Shea made two nice donations to the Food Pantry
- Fuss & O'Neal Engineering made a \$1,000 donation to the Food Pantry after they saw how long the line was for the community food giveaway event.

#25-138 **RESOLUTION TO APPOINT DR. YUWEI CHEN AS
CIS/PROGRAMMING FOR GAME DEVELOPMENT INSTRUCTOR**

WHEREAS, it has been recommended that Dr. Yuwei Chen be appointed as the CIS/Programming for Game Development Instructor; and

WHEREAS, Dr. Chen has indicated that he will accept the position if offered by the Board of Trustees; and

WHEREAS, the President concurs with said recommendation, it is hereby

RESOLVED, that Dr. Yuwei Chen be appointed as CIS/Programming for Game Development Instructor at a prorated annual salary of \$49,978 for the period of January 12, 2026 to August 31, 2026. The salary for the remainder of AY 2025-26 is \$37,484, which will be funded by SUNY Additional Operating Aid through August 2026 (as will his benefits). Subsequently, the position will be funded by operating funds. This appointment is governed by the terms and conditions of employment as set forth by the personnel policies of the Board of Trustees and is consistent with the terms and conditions as set forth in the Union of Faculty and Professionals (UFP) Agreement.

WHEREAS, it has been recommended that Shawna Reilly be appointed as a Program Coordinator, Liberty Partnerships Program (LPP); and

WHEREAS, Ms. Reilly has indicated that she will accept the position if offered by the Board of Trustees; and

WHEREAS, the President concurs with said recommendation, it is hereby

RESOLVED, that Shawna Reilly be appointed as a Program Coordinator, Liberty Partnerships Program (LPP) at a prorated annual salary of \$48,000 for the period of January 6, 2026 to August 31, 2026, funded by the LPP Grant. This appointment is consistent with the terms and conditions of employment as set forth by the Personnel Policies of the Board of Trustees (Unrepresented) and the terms and conditions of employment as set forth in Board Policies 2.2, Temporary, Grant-Supported Staff Positions and Temporary Assignments.

FURTHER RESOLVED, the grant-funded reappointment may be terminated prior to the end of the 2025-2026 academic year, upon expiration of grant funding. Should the funding source end, the salary and benefits will be reduced accordingly.


BE IT RESOLVED, the Board of Trustees approves the updated Naming of College Facilities, Areas, & Roads policy.
