Memorandum of Understanding

Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act

This Memorandum of Understanding, entered into by and between Schenectady County Community College ("SCCC" or "College"), with its principal place of business at 78 Washington Avenue, Schenectady, NY 12305, and the Town of Glenville Police Department with its principal place of business at 18 Glenridge Road, Glenville, NY 12302 (referred to hereafter collectively as "Parties"), sets forth the respective rights and responsibilities with regard to the coordination of law enforcement response and reporting between the parties pursuant to the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act (Clery Act) and Title IX of the Higher Education Amendments of 1972.

Parties to this Memorandum of Understanding hereby agree as follows:

- 1. The Town of Glenville Police Department has primary law enforcement jurisdiction on all property within the geographical footprint of the Town of Glenville that is owned, leased, or under the control of the College and will provide services on said property, except as otherwise specified in the Memorandum of Understanding.
- 2. The College has leased two classrooms and an office on the second floor of the Richmor Building at the Schenectady County Airport in the Town of Glenville, to operate its aviation and air traffic controller programs (referred to hereafter as "the property").
- 3. The College shall take reasonable steps to notify the Town of Glenville Police Department of any incident or situation on the property that may affect the safety and/or well-being of any individual(s) on said property or within a reasonable proximity thereto.
- 4. The Town of Glenville Police Department will notify the SCCC Director of Campus Safety of any incident or situation within the Town of Glenville that may affect the safety of any individual(s) on the property.
- 5. When Town of Glenville Police Department executes a warrant on the property, it will contact the SCCC Director of Campus Safety and request that person to accompany the executing officer onto the property. Efforts will be taken to refrain from interrupting an academic learning environment to affect an arrest or execute a search warrant, subject to and depending upon exigent circumstances. In the event of continuous close pursuit beginning in the jurisdiction of the Town of Glenville and continuing onto the property, the Town of Glenville Police Department will notify the SCCC Director of Campus Safety as soon as possible. The number of arresting officers will be limited, as appropriate, to execute the warrant.
- 6. For major non-emergency events affecting either Party, the designees from the Town of Glenville Police Department and the College will meet in a timely manner to review various protocols and operational issues including, but not limited to, traffic planning, scheduling for additional personnel, mitigating and responding. This includes a willingness to provide appropriate annual Clery Act Crime and Fire Report related data upon request from the Director of Campus Safety.

- 7. The College agrees to include Town of Glenville Police Department in any timely warnings and *I* or emergency notifications distributed from the College. The Parties agree to participate in at minimum one Drill, Table Top, Functional, or Full Scale Exercise annually.
- 8. The Parties may enter into more specific and detailed operational procedures and guidelines, provided that such additional items are not inconsistent with the provisions of this Memorandum of Understanding.
- 9. Either party may terminate this agreement by notification in writing to the other as noted in this Memorandum of Understanding.
