If you otherwise qualify but have not lived in Schenectady County for the past six months, you will need to obtain a Certificate of Residency from your home county.

- o In order to qualify for resident tuition, this affirmation must be completed and submitted to the College annually.
- o The completed affirmation must be submitted at the time of bill payment, but no later than 29 days after the first day of classes.
- o Failure to submit the affirmation may disqualify you from receiving the resident tuition rate, and you will be required to pay the higher, out-of-state tuition.
- Out-of-state tuition is charged to students who do not have United States citizenship or are an eligible foreigner, have not lived in New York State during the past twelve months and to students who fail to submit a completed Affirmation of Residency with supporting documentation (for Schenectady County residents) or a valid Certificate of Residence (from New York State residents who live in another county).
